Government of Maharashtra Scholarship for the Minority Communities Students pursuing Technical and Professional Education / All Courses after H.S.C.(Arts,Commerce and Science)

Ministry of Minority development, Government of Maharashtra is offering the Scholarship for students pursuing Professional and Technical courses /All courses after H.S.C.(Arts,Commerce and Science) education for the economically weaker and meritorious students belonging to **Muslim, Sikh, Buddhist, Christian Parsi and Jain** minority communities

Applications are invited through **Offline/Online Application System** for Fresh Scholarship from **all students admitted in first year to final year** and Renewal of the scholarship for academic year 2009-2010.

❖ Eligibility and required documents: For all courses

1. Applicant should be Domicile of Maharashtra State and pass S.S.C from Maharashtra.
2. Admission to the course should be through Common Entrance Test / without Common Entrance Test .
3. Applicant should not avail any other scholarship / stipend.
4. The total annul income of family/guardian should not be more than **2.50 lakhs**.
5. For renewal, applicant must have admitted in the next year.
6. 30 % seats are reserved for girls students.

❖ Documents to be attached with application form :

1. One Copy of passport size photograph with signature pasted on Application form.
2. Attested certificates of educational qualification (S.S.C.Onwards).
3. Income and minority declaration - affidavit on non-judicial stamp paper of minimum Rs.10/- and income certificate from the employer, if any.
4. Proof of permanent residence- Any one attested copy of Domicile Certificate/Ration Card/Electricity bill/Telephone bill/Passport/Election Card etc.

● For renewal of scholarship only income declaration and previous year marksheet is to be attached along with application form having Form No. of A.Y. 2008-09 ●

❖ Courses for Scholarship:

➤ A) Technical and Professional :-

The professional and Technical courses Diploma / Degree in Engineering/Technology UG & PG (B.E. / B. Tech/ M. E. / M. Tech), Cement Technology, Fashion Technology, Pharmacy (B. Pharm / M. Pharm), Architecture & Town Planning (UG & PG), Hotel Management & Catering Technology, Applied Art & Craft (UG & PG), MCA, MBA/MMS, Law (LLB/LLM), Veterinary Sciences and Animal Husbandry, CA , ICWAI, CS etc.

➤ B) All courses after H.S.C.(Arts ,Commerce and Science Courses)

❖ Procedure for Submission of Application Form :

A) For- (Technical and Professional) courses :

The eligible aspiring candidates shall fill the online application form on www.dte.org.in/mcm At the time of filling of form, the system shall generate Application ID through which the candidate shall know the status of Application. The candidate has to note down the Application ID and password for further use. The candidate should take the printout of the Application form, attach required documents and submit to the concerned institute. The messaging facility is available to the candidate to interact with Regional Offices or Directorate.

❖ **Procedure for Scrutinising and Forwarding Application Form :**

1)The institutes under Directorate Technical Education (DTE):

Institute shall log on to the Online System as per the Institute Code and Password provided by DTE, scrutinize the applications received, confirm the application form through login and issue the receipt of confirmation to the candidate and forward the scrutinized application form along with report to the concerned Regional Office of Technical Education.

2)The institutes under other Directorates in Maharashtra :

Institute shall **manually** scrutinize the application form and forward to the concerned Regional Office of Technical Education.

3)The recognized institutes in India, but outside Maharashtra :

Institute submit the **manually** scrutinized application forms to the Nodal Officer directly. The institute should send the Applications in batches, instead of waiting for the last date.

B) For- Arts, Commerce and Science Courses :

The eligible aspiring candidates should download the application form from www.dte.org.in/mcm and submit it to the concern institute along with required documents.
